NOTIFICATION

Applications are invited from eligible candidates for the engagement as **Intern (Legal) in Kerala State Electricity Regulatory Commission (KSERC)**. Interested candidates may forward their application through online to the Secretary, Kerala State Electricity Regulatory Commission, KPFC Bhavanam, C V Raman Pillai Road, Vellayambalam, Thiruvananthapuram 695010.

Educational Qualifications

1. Fresh graduates holding LL.B. Degree from a recognised University are eligible to apply for the Internship Programme of KSERC for the year 2026-27.
2. Candidates who are awaiting publication of LL.B. results in June 2026 may also apply. However, the relevant mark lists and certificates shall be produced at the time of the written test.

General Conditions

1. The Internship Programme is strictly for a period of one year.
2. Age Limit:-
 - a) In the case of candidates who have pursued the 5-year integrated LL.B. course after Plus Two, the upper age limit shall be **23 years** as on the date of notification.
 - b) In the case of candidates who have pursued the 3-year LL.B. course after graduation, the upper age limit shall be **24 years** as on the date of notification.
3. Eligibility:-
 - a) The candidates who have passed out in first chance only will be considered.
 - b) Proficiency in Malayalam and English is mandatory.
 - c) Knowledge in computer applications, namely word processing, spreadsheet and PowerPoint presentation, is essential.
 - d) The candidates should have obtained a minimum mark of 80% or equivalent in 10th and 12th standard.

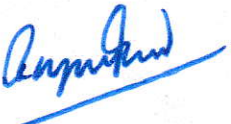
- e) The candidates should have secured a minimum CGPA of 6.5 (60 % and above of the total marks in the course) in the qualifying LL.B. Degree.
4. The stipend payable shall be Rs 25,000/- (Rupees Twenty Five Thousand Only) per mensem.
 5. The application shall be submitted through online mode only.
 6. The last date for receipt of applications shall be **at 5.00 P.M on 07-07-2026**

Selection Process

1. The selection will be based on Online Multiple Choice Objective Type Test and a Personal Interview.
2. The Online Multiple Choice Objective Type Test will consist of 100 questions with duration of 90 minutes. There will be negative marks for wrong answers.
3. Questions for the test will be divided into 5 sections as detailed below:-

1	Knowledge in Law (Graduation Level)	50
2	English Language	20
3	General Knowledge	20
4	Logical Reasoning	10

4. The applicants will be shortlisted for interview based on the marks scored in the online test.
5. Shortlisted candidates alone will be invited for a personal interview.
6. The rank list will be drawn based on the combined score in the online test and personal interview.
7. If the numbers of applications are large, the Commission reserve the right to screen the applications prior to examination.
8. The application shall be submitted through online mode only using the link available in the website of the Commission (**application.kserc.sbs**)
9. The Commission also reserves the right to cancel/modify this notification at any time without stating any reason whatsoever.
